Status from each center and registry

Helsinki – Lauri Kyllönen has stopped and Kaija Salmela will do so shortly, next year it is most possible Marko Lempinen who will join NKG. Transplantation of intestines has started, and until now four has been performed. A new National Kidney registry is coming shortly.

Oslo – The number of annual Pancreas transplantations is projected to 40-50 a year, until now 30 has been performed, where half was single pancreas. København – very close to start pancreas transplantation. Several centers are expiring low donor-rates.

Status on Kidney exchange compliance

In the first 10 months of 2013 a total of 318 searches for recipients in relation with a deceased donor were done in the database.

In 14% (44 of 318) of these searches exchange obligation(s) occurred. In 6,8% (3 of 44) the exchange rules was not followed, due to a minor deviation, which was

In 6,8% (3 of 44) the exchange rules was not followed, due to a minor deviation, which was accepted.

Evaluation of the exchange rules.

Exchange obligation 2 (Immunized patients (PRA \geq 10% but below 80%) who are HLA-A,-B,-DR compatible with donor) and 3 (Patient with STAMP-status) has now shifted prority.

Kidney payback overview

Import/Export status is in a good state. However, not all centers send HLA-type when offering a pay-back organ making it impossible to check for suitable recipients.

Kidney Paired Exchange Program within the Nordic countries

All countries except Finland (their law only allow LDtx between Next of Kin) was willing to investigate further into the possible amount of LD at each center.

The upcoming NKG meeting has been dedicated to the issue, where also Immunologists will be participating.

Status on NLDR

At the next meeting the entered amount of Possible mandatory and voluntary fields suggested in 2010, will be presented.

Status on Nordic kidney registries

The national data shall be delivered to Scandiatransplant Apr. 1 2014 at the latest. Before the actual import Torbjørn Leivestad will come to Aarhus and do a Test-run based on the Norwegian data.
