Kidney balance

Every center informed in details about the organs expected or owed.

In a few cases YASWA was used to seek information and some disagreements was to be followed up after the meeting by email.

Liver balance

Same procedure as kidneys There was a talk about payback in relation with multiviseral transplantations, it is important to agree on and be clear about payback in these special organ exchange situations.

YASWA: New facilities - Deceased donor definitions - Wishes - Problems

Wishes: That the current label in the Organ offer form "Other cause of death" is changed to "Noth on death".

A new field for time and date of death of the donor will be added, LOV in Infection serology should change sort order, request a clear difference in colour to distinguish between the different values for Infections.

HLA will be removed from the organ form, it must be extracted from YASWA.

Deceased donor death cause

It has been decided that a revision of the 'deceased donor death causes' in Scandiatransplant is needed. The board has appointed 1 person from each country to participate in a working group (WG), that must bring forward a proposal for the council meeting in Helsinki May 10th, 2017.

Definition of each death cause will be made by the WG as a supplement. The group discussed the new list and found it sufficient.

Information from latest NLTG meeting

Based on import/export between the countries during the last 10-years it has been decided by the liver group that Göteborg and Stockholm should be represented on the same line on the rotalist.

The two Swedish centers will internally sort out who is to accept an organ offer.

However, at the moment there is no better solution.
