1. New Organ offer form

We are happy to announce that the final tests of the organ offer form went smoothly, therefor the form will as planned be set in action from **12th of June 2013**.

From this day **spare organs** in Scandiatransplant must be offered by using this form, both when offers are made internal Scandiatransplant and out of Scandiatransplant to the other European Organ Exchange Organizations.

When the offer is sent, you yourself will also receive the offer. *In the beginning please be very aware that you in fact receive the offer as this is an assurance of the offer being sent correctly.*

If you register the deceased donor in the 'old' database first, you will be able to make a search in the new organ offer module and bring forward all the information you have already registered.

On the other hand if you wish to register the information in the organ offer form first, the data will be transferred to the 'old' database within one day. When you choose to do it this way we ask you not to register the donor yourself in the 'old' database, as the donor will be registered twice with two different donor numbers.

Traceability is one of the major goals of EU directive 2010/25/EU

Therefor we ask you to remember to fill out further information in Scandiatransplant when you export organs out of Scandiatransplant. In the menu 'Recipient Center: Usage Of Received Organs' you must state if the organ was transplanted, what center the organ was exported to and traceable patient ID.

If you do not find the center you have exported to in the list 'Foreign Tx center' please let us know, then we will add it to the list.
