# 6. Annual report:

Søren Schwartz Sørensen presented completed data from the registry. No major changes or clear trends in any direction were observed for 2024 compared to previous years.

#### 7. Data completeness NPRTSG:

Ilse Duus Weinreich presented how well different centers have registered follow-up data. Unfortunately, Stockholm, unlike most other centers, had not registered any follow-up data at all.

#### 8. Status on ERN TransplantChild and PETER Registry (LW online):

Lars Wennberg provided information about ERN Transplantchild and encouraged all centers to be active within this ERN by discussing patients via the Clinical Patient Management System (CPMS 2), contributing to work on guidelines and training, or alternatively making use of the available material. Stockholm is most active to include patients in PETER registry so far. No news regarding cooperation among different EU registries under ERN. Consent is mandatory but varies between Nordic countries.

#### 9. Discussion about exchange obligation 4.

Helle Charlotte Thiesson raised the question of whether the age of a pediatric recipient in "exchange obligation 4" in the Scandiatransplant exchange program (i.e., that a kidney from a deceased donor younger than 50 years with mismatch 2-0 should be offered to a pediatric recipient) should be increased from 16 to 18 years, and whether the kidney should be offered even if there is more mismatch. Helena Genberg pointed out that not only the number but also the type of mismatches matters. It was also noted that if there is a living donor, a more pronounced mismatch can be considered compared to a deceased donor. It was approved that Søren S. Sørensen should bring forward the suggestion to NKG to increase the age from below 16 to below 18 years of age and to further discuss the HLA matching.

After lunch, two highly appreciated lectures were held (attached):

- **10.** Kidney transplantation for severely neurologically compromised children ethical considerations (Anders Castor, Chair of the Medical Ethics Delegation within the Swedish Society of Medicine)
- **11**. *Intellectual disability what does it mean?* (Maria Forsgren, pediatric neurologist, Lund)

Following this, four cases were presented concerning children with significant intellectual disabilities and severe kidney failure, where we discussed the pros and cons of kidney transplantation. It seems that we have similar ethical considerations and difficulties in decision making for this growing group of patients (Sweden, Denmark and Finland).

We concluded that difficult cases can be discussed in this NPKTSG to gain more experience and support for decision making.

# 12. The date for the next NPRTSG meeting was set for November 10<sup>th</sup> 2026, and Finland will host this meeting.
