#### **New PDF format**

As with all other files generated as PDF within YASWA, the files sent by e-mail will now be updated to a new and improved format. This includes SAE/SAR, Organ Offer Form, Urgent waiting list, Kind request, and Visceral and pediatric liver waiting list.

All PDF preview options have been updated. And the print option under kidney recipient search has also been updated.

### New 'Deceased donor organ form'

The 'Deceased donor organ form' has also been converted to the new PDF format, furthermore it has been modified according to the wishes from the WG of transplant coordinators.

This includes the introduction of two forms – one for DBD donors and one for cDCD donors, which is automatically selected by the system depending on the donor type. This is the first version of the forms in the new layout, so it might need some adjustments along the way.


Donor -> Deceased donor -> Coordination -> Allocation.



### User defined columns in kidney recipient search overview

In the kidney recipient overview, it is now possible to define which columns you would like to have shown. To do this, click on any column and go to 'Columns', then remove the tick for the columns that you do not need. Your choices will be stored and visible the next time you enter kidney search. You can always re-edit the list of columns you wish to see.


Removing columns will automatically make some fields longer, including the fields for scandia number and DSA.

### Additional information in exchange option overview

In the exchange option overview within Deceased Donors, additional information has been added. This includes information on recipient age, recipient height, and recipient weight.




### 'Cause of death' obligatory after 'Donation realized'

Before this update, 'Cause of death' was an obligatory field at the creation of a donor. We have been made aware that this is not always convenient, so after the update 'Cause of death' isn't obligatory until after 'Donation realized' is set to 'Yes'.

### Choose one or more surgical techniques for NRP

For the field 'Surgical technique' within the NRP tab, it is now possible to enter more than one option.

On recipients below the current waiting list table, it is possible to add information about transplantations that are not found in YASWA, this includes kidney transplantations (without donor info) done before 01-jan-1995 and transplantations done outside SCTP.

### Measurement during DCD for all cDCD donors

#### Tab for 'Measurement during DCD'

The tab 'Measurement during NRP' has been renamed to 'Measurement during DCD' and has been made available for all cDCD donors. The tab appears next to the 'cDCD' tab.



Decision taken of withdrawal of lifesustaining treatment for DBD donors

### 'Decision taken of withdrawal of lifesustaining treatment'

'Decision taken of withdrawal of life-sustaining treatment' is now available for both cDCD and DBD donors. The field is found under the coordination tab.



## Semi-obligatory fields in the heart and lung registry

Semi-obligatory fields in thorax registries with warnings At the last SHLG meeting, it was decided to introduce several semi-obligatory fields for the different forms in the heart and lung registries, this in the effort of improving the data entry.

If trying to save without data in these fields, a pop-up warning appears, and a red exclamation mark is shown next to the relevant fields. It is possible to dismiss the warning and save without entering data in the semi-obligatory fields.

### Possibility to select an EDTA diagnosis

It is now possible to select an EDTA diagnosis for all kidney waiting lists.



### Liver registry, data entry completeness

In February 2023 a liver registry workshop was held, and it was decided to develop a solution for the users to investigate completeness of data entry in the registry directly in YASWA.

We now have a solution ready, which includes two different reports for each form. The first report gives an overview of data completeness in the form of a percentage for each parameter, and the second report gives information on which scandia numbers are missing data on the same parameters.

You can choose whichever date interval you wish to look at for Form A, B and D. For Form C, it is also possible to choose whichever date interval, but it is currently only possible to see information on 1-year follow ups. If you want additional follow-up information, let us know.



entry


